1. Who We Are

2. Information We Collect

We may collect:

- **Technical Data:** IP address, browser type, operating system, and how you interact with our site.
- **Usage Data:** Pages visited, time on site, and preferences.

3. How We Use Your Information

We process your data to:

- Provide and improve our services.
- Match clubs and players.
- Respond to enquiries.
- Send updates, news, and offers (only if you opt in).
- Maintain website security.

4. Marketing Communications

If you have opted in, we may send you marketing emails about our services, events, offers, and relevant football-related content. You can unsubscribe at any time via the link in our emails or by contacting us.

5. Marketing Consent

By ticking the marketing consent checkbox on our forms, or signing up to the Locker Room section you confirm that:

- You consent to receive marketing communications from **The Non-League Network** by email (and/or other channels specified at the point of opt-in).
- You understand you can withdraw consent at any time by clicking the unsubscribe link in our emails or contacting us directly.
- Your consent is freely given, specific, informed, and unambiguous, in line with the UK General Data Protection Regulation (UK GDPR) and the Data Protection Act 2018.

6. Legal Basis for Processing

We rely on:

- Your consent (for marketing).
- Contractual necessity (to provide services).
- Legitimate interests (for analytics, security, and service improvement).
- Legal obligations (where required by law).

7. Sharing Your Information

We may share data with:

- Trusted service providers (e.g., hosting, email services).
- Regulatory authorities if required by law.
- We never sell your data.

8. International Transfers

If your data is transferred outside the UK/EEA, we ensure it's protected with appropriate safeguards.

9. Data Retention

We keep your data only as long as necessary for the purposes stated above or as required by law.

10. Your Rights

You have the right to:

- Access, correct, or delete your data.
- Withdraw consent for marketing.
- Request a copy of the data we hold about you.
- Lodge a complaint with the ICO (www.ico.org.uk).

11. Children's Privacy & Data Protection

- The Non-League Network does not knowingly collect or process personal data from anyone under the age of 16.
- Members aged 16–18 are permitted to register but should do so with the knowledge and consent of a parent or guardian.
- If we become aware that we have inadvertently collected personal data from a child under 16, we will delete that account and all associated data immediately.
- All personal data is handled in accordance with GDPR and the UK Data Protection Act. This includes safeguarding measures to ensure that any data relating to under-18 members is treated with the same level of protection as adult members.
- We encourage under-18 members not to share personal contact details publicly and to use the platform responsibly.
- Parents or guardians who have concerns about their child's data on our platform may contact us directly to review, amend, or request deletion of the account.
