1. Who We Are

2. Our Services

We provide an online platform for clubs, players, and the wider non-league football community to connect, post opportunities, and view content provided by The Non-League network. Some services are free; others require a paid subscription.

3. Registration & Accounts

- You must provide accurate and truthful information when registering.
- You are responsible for keeping your account secure.
- We reserve the right to suspend or terminate accounts that breach these terms.

4. Subscription Plans & Payments

- Details of subscription plans, features, and pricing are shown on our website.
- By purchasing a subscription, you agree to pay the stated fees at the time of order.
- Payments are taken in advance for the agreed subscription period (monthly, quarterly, or annually).
- We use secure third-party payment processors; we do not store your full payment details.

5. Refunds & Cancellation

- Under the UK Consumer Contracts Regulations, you have a **14-day cooling-off period** from the date of purchase to cancel your subscription and receive a full refund, provided you have not started using the paid service.
- If you begin using the paid features within the cooling-off period, you agree that the service has been supplied and you will lose your right to a full refund.
- After the cooling-off period, subscriptions are non-refundable unless required by law.
- You can cancel your subscription at any time through your account settings; cancellation will take effect at the end of your current billing period.

6. User Content

- You retain ownership of any content you upload.
- By posting, you grant us a non-exclusive, royalty-free licence to display and share your content on our platform.
- You must not post unlawful, defamatory, or infringing material.

7. Prohibited Activities

You must not:

- Misuse the platform for spam or malicious purposes.
- Impersonate another person.
- Attempt to hack or disrupt the website.

8. Our Rights

We may modify, suspend, or discontinue services without notice.

We may update subscription prices; any changes will be communicated at least 30 days in advance.

9. Liability

We are not responsible for:

- The accuracy of user-submitted content.
- Any loss or damage resulting from use of our platform, except where required by law.

10. Eligibility & Safeguarding

- Membership of The Non-League Network is open to individuals aged 16 and over.
- If you are under 18, we strongly recommend that a parent or guardian is aware of your registration and activity on the site.
- All content posted by members must be respectful, football-related, and appropriate for a community that includes under-18 players.
- Direct communication with clubs, players, or other members must remain professional and football-focused at all times.
- If we become aware that a member is under the age of 16, we reserve the right to suspend or delete their account immediately.
- The Non-League Network reserves the right to moderate, restrict, or remove any content or communication that we consider unsafe, inappropriate, or in breach of these Terms.
- By using the site, you confirm that you are at least 16 years old and that you agree to abide by these Terms and our Community Guidelines.

11. Player Contract Disclaimer

Posting a player profile or sharing content on this platform does **not in itself constitute a breach of contract** with any football club. However, players remain responsible for ensuring that they comply with:

- Any contractual obligations they have with their current club.
- The FA's regulations on player registrations, approaches, and transfers.
- Their club's code of conduct, including the use of social media.

This platform provides a space for players to showcase their talent and connect with opportunities. It does not act as an intermediary or make direct approaches to clubs on a player's behalf.

Players under contract should seek guidance from their current club before entering into discussions or agreements with another club.
